Why?	Financial companies choose how they share your personal information. US federal law gives consumers the right to limit some but not all sharing. This information can include:</p> <ul style="list-style-type: none">■ Information we receive from you on applications, questionnaires, subscription agreements or other forms, including, but not limited to, your name, address, social security or other tax identification number, age, employment information, assets owned and income.■ Information about your transaction with us, our affiliates or others, such as your account balance and holdings, payment history and transaction information.■ Information we may receive from our due diligence, such as your credit worthiness and your credit history.■ Information obtained from our communications and correspondence with you.
